




**Interpretation**: Out of 100 respondents, 79 respondents said that PUC certificate is useful to protect the environment. This shows that environment awareness is there among the people.







Comments: - As per Table NO. 4 it is cleared that customers are responsible behind not using issuing of PUC certificate procedure. Out of 100 respondents, 59 respondents are not forcing for implementing the procedure of issuing PUC certificate. The mentality of customers should be changed. Similarly, PUC center agent should take initiative for using proper procedure of issuing PUC certificate.

## FINDINGS OF THE STUDY

- 1. Positive sign of the research study is that people are aware that issuing of PUC certificate is useful to protect the environment.
- Government should make it compulsory agent to do the registration.
- 3. Out of 100 respondents, 26 respondents said that agents are not having proper license.
- 4. Out of 100 respondents, 59 respondents are not forcing the agent to implement the procedure of issuing PUC certificate.
- 5. Out of 100 respondents, 61 respondents are taking PUC certificate after the expiry of validity period.

## RECOMMENDATIONS

- Before issuing driving license, create awareness about PUC certificate.
- The awareness campaign should be conducted at all level i.e. at customer level as well as at agent level.
- Board offices should be set up in each area who can monitor the working of PUC agent in their respective area.
- Enforcement of punishment against those who are not having PUC certificate
- After expiry date if customers are taking PUC certificate, heavy penalty should be charged.
- The agent, must have license of Pollution control board.
- Renewal period should be thrice in a year
- There should be cash prizes or certificate of merit who follow the rules and procedure.
- Need to create awareness about online procedure of obtaining PUC certificate
- Need to increased the number of agencies. At present only 87 agencies in Mumbai.
- Need to publish the record of Green fund.
- Maximum use of public transport.

## CONCLUSION

With the help of research study, it is concluded that the purpose of issuing of PUC certificate is not fulfilling the requirement of protection of environment. In fact it is an income generating source for agents in the present scenario.

This situation may change in the near future by creating awareness among the agent as well as among the customers. Similarly, Government has to take necessary initiative for implementing the procedure of issuing PUC certificate.
