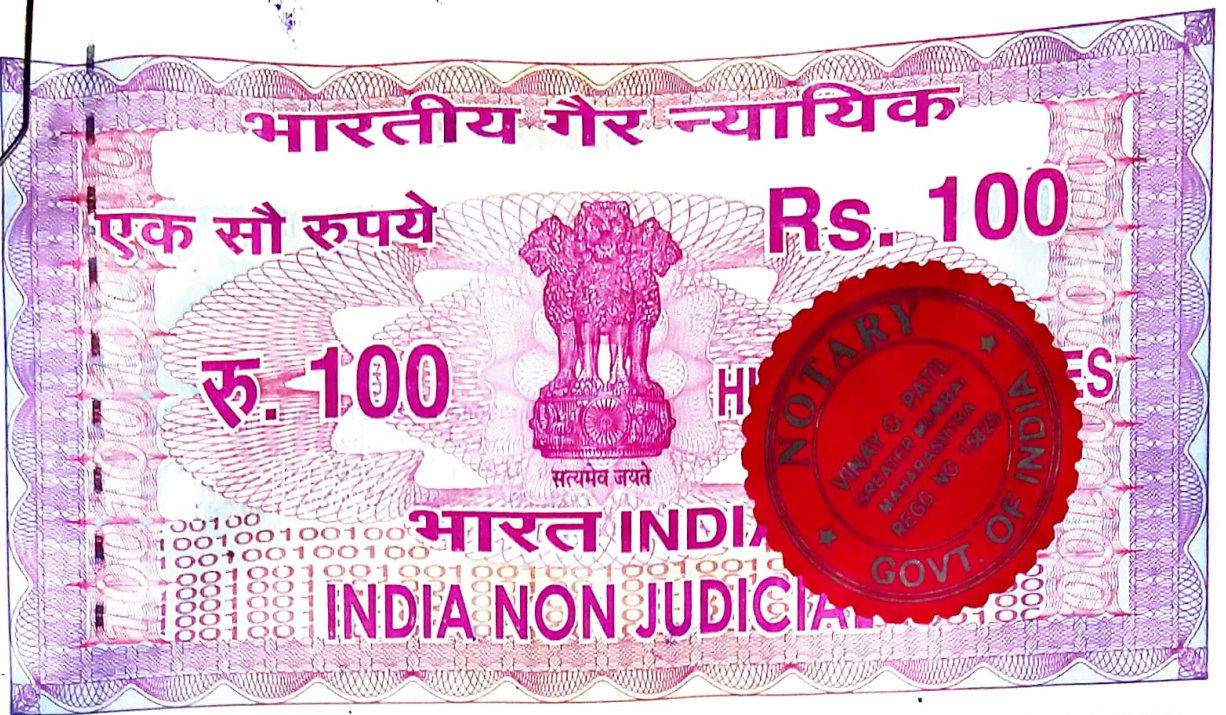

International Association for Human Values (IAHV) with its headquarters at 216-C, Humayunpur, Opp. B-6/98, Safdarjung Enclave, New Delhi 110029 and represented by its Project Manager, Viraj Gidh, **hereinafter called the Second Part or the Second Party**, which unless repugnant to the context or meaning thereof, will include its successors-in-interest and assigns, on the **OTHER PART**.

WHEREAS, the first party has been established under Mumbai University to provide education and research in various branches of Arts & Commerce and to disseminate knowledge in these branches and is engaged in the providing education at affordable cost to the people of this country.

AND WHEREAS, the second party is a not-for-profit organization engaging in nationwide initiatives addressing disaster relief, skills training leading to employability and entrepreneurship, health, WASH (Water, Sanitation and Hygiene), education, and environmental sustainability.

NOW THEREFORE, the aforementioned parties have agreed to the terms and conditions as mentioned hereinafter in order to provide employability training sessions for the final year students to upskill them so that they are better prepared to get suitable job opportunities and to enter the workforce.

Both the parties believe that close cooperation between the two organizations would be a major benefit to the student community.

I. OBJECTIVES

1. Both parties share a common intent to disseminate and advance knowledge; and to upskill final year students across all disciplines.
2. This collaboration is intended to provide the students opportunities and exposure to help them to be better prepared for job opportunities and to enter the work force.
3. The collaboration between the two institutions shall be as follows:
 - a) The College and IAHV shall work together to create a training schedule for the final year students.
 - b) The proposed activity schedule shall not affect the academic schedule of the



college.

- c) The College shall make the students available as per the agreed schedule and shall provide classroom space in the college as required for the training.
- d) IAHV shall conduct the employability training program for the students.
- e) Each training session shall be for a minimum of 60 students and at least two such programs shall be done (total 120 students).
- f) IAHV shall have the option to not conduct the sessions if the minimum number of students are not present for the session.
- g) IAHV shall also provide career guidance to students where possible.
- h) IAHV shall also provide opportunities for students to interact with the industry where possible.
- i) Once the student is placed by the College, the College shall provide a copy of the student's offer letter to IAHV.
- j) The data shared with IAHV shall be kept confidential and shall only be used to report the success of the program to IAHV's donors.
- k) IAHV shall use appropriate branding of IAHV's donors during the training sessions.
- l) The College and IAHV can change the scope of the program after mutual discussions.

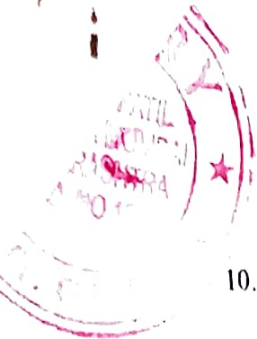
II. NATURE AND SCOPE OF UNDERSTANDING

Both parties shall not render any other service other than that mentioned in this MOU, unless otherwise agreed upon by the parties.

NOW THIS AGREEMENT WITNESSES AS FOLLOWS

1. This MOU is valid for a period of one year which can be renewed further from time to time as per the mutually agreed terms and conditions.
2. Both the Parties may terminate the MOU at any time by giving 2 months' notice in advance to the other party.
3. The students to follow the code of conduct to help maintain the reverential ambiance of the respective institutions.

4. There shall not be any financial commitment by both parties as a part of this engagement.
5. The College shall not share the student's Offer Letters and employment details with any other organization and it will be IAHV's exclusive right to use the data. Any breach of this exclusivity shall automatically be considering as breach of trust and shall amount to termination of this Agreement effective immediately when the non-compliance is brought to IAHV's attention.
6. If a party's opinion that a conflict of interest has arisen while carrying out the Services including by reason of change in the party's ownership, copyright or other scenarios, then a party shall be entitled to rescind the Agreement by written notice to another party.
7. The Parties herein agree that the provisions pertaining to confidentiality shall continue even after the termination of the MOU for a period of 6 months.
8. This MOU may be modified in writing by mutual consent of authorized officials from the two Parties. This MOU shall become effective upon signature by the authorized officials from both the partners and shall remain effective until modified or terminated by any one of the partners by mutual consent.
9. This MOU shall be governed by and interpreted in accordance with the Indian laws and shall be subject to the jurisdiction of the courts of Maharashtra. For any dispute or difference arising under this MOU, the parties shall endeavor to resolve the same in good faith through mutual dialogue/discussions/negotiations. In the event of failure of such dialogue /discussions/negotiations, the matter shall be referred to a binding arbitration under the rules of arbitration and Conciliation Act 1996. The dispute between the parties shall be adjudicated by a Sole Arbitrator to be nominated by the parties herein on mutual consent. The arbitration shall be in English language and the venue of arbitration shall be at Maharashtra, India. The costs of such arbitration shall be borne on the basis of the award passed by the arbitrators.



10. All publications whether through print or any other media connected with the activities pertaining to this MOU will be done after review and express approval of both the parties herein.

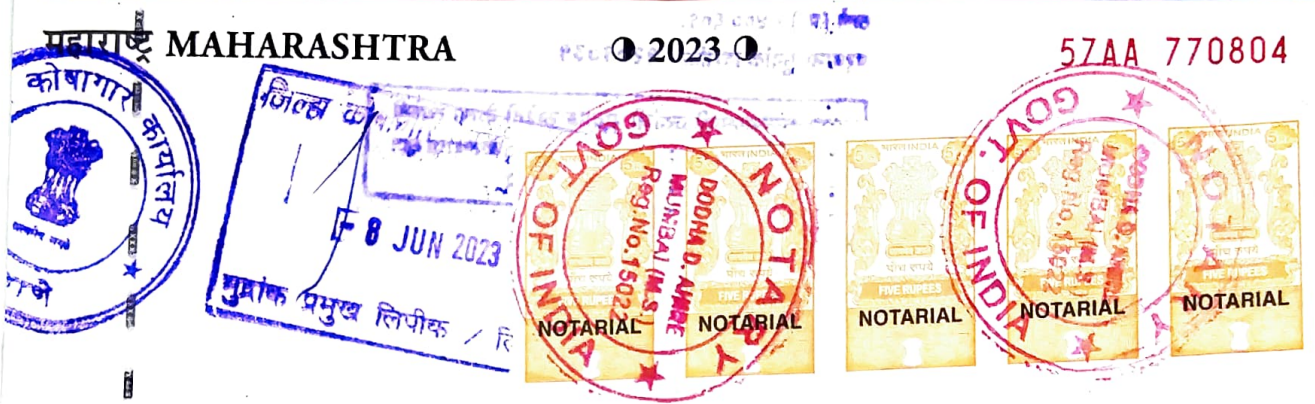

WHEREAS:

1. First Party is engaged in carrying on and imparting information, knowledge and practical know how as the educational activities including Training Courses in Banking.
2. Second Party is an educational institution affiliated to Mumbai University carrying on and imparting education in various streams of Recognized Degree Courses.
3. Pursuant to the discussions, the First Party and Second Party agree to impart knowledge, information and know-how by way of "OneInfini Consultancy's Complete General Banking programme" at location of K. B. College of Arts and Commerce for Women, Thane (herein after called the said Centre) as a Educational Course, upon the terms & conditions more particularly set out herein.

NOW THE PARTIES HEREBY AGREE AS FOLLOWS:

1. First Party agrees to conduct Banking programme called "Complete General Banking programme" in the manner and conditions as and when indicated and stipulated by the First Party.
2. Second Party grants to the First Party, its permission to conduct the above mentioned Course as value added Course.
3. Second Party agrees that no revenue will be collected by the First Party from the participants without the consent of college management.
4. Detailed topics of the course are mentioned in Annexure 1.
5. First Party agrees that it will be responsible for conducting the course by lectures and power point presentation, recording attendance, assigning projects, assessing such projects, declaring the results of projects / assignments. The projects / assignments will be the responsibility of First Party and their ownership for purpose of records to be maintained by them for three years from the date of certification.
6. First Party agrees to appoint lecturer/s for conduct of said course and shall be solely responsible not to seek or depend upon Second Party for completion of said course. All expenses as to conduct of said course including lecturers/ faculties/delegates from fields, kit, material, power point programmes, software etc. will be the responsibility of the First Party.

7. First Party shall take responsibility of Certification and felicitation immediately after completion of course on declaration of results and get duly signed by Principal.
8. Entire course till certification and felicitation will be conducted by co-ordination of both parties and suggestions during the course will be well taken in co-operation by both the parties.
9. Second Party shall help in marketing the programme through its existing established network as and when required. Second Party shall nominate a coordinator as a point of contact (POC) for the First Party to ensure proper coordination of activities.
10. First Party will always have rights over projects, assignments, course material, study material, systems and conduct of entire course. First Party can implement changes as their rights in conducting the said course as required.
11. In case of any disagreement, both parties agree to sort out issues amicably.
12. Either party shall have the right to terminate this Agreement by giving written notice of termination to the other by registered post on the address given. The Agreement shall terminate on the 10th day after such notice of termination, in case of substantial breach by the other party of the obligations arising from the contract, or in case of exceptional circumstances justifying the earlier termination. The Second Party has the right to terminate the agreement for non-performance of the First Party.





MEMORANDUM OF UNDERSTANDING

THIS MOU has been entered on this month of 26th June, 2022

BETWEEN

“SIDDHARTH COLLEGE OF COMMERCE & ECONOMICS,” having its college premises situated at Fort, Mumbai- 400001 represented by Its I/C Principal **Dr. Umaji M. Maske** here in after referred to as ‘COLLEGE’ (which there shall be wherever the context so requires, mean and include its successors and assigns) of the “**FIRST PARTY**”

“K. B. COLLEGE OF ARTS AND COMMERCE FROM WOMEN,” having its college premises situated at **Kpari, Thane- 400603**, represented by its I/C Principal, **Dr. Seema Jha** here in after referred as ‘COLLEGE’ (which there shall be wherever the context so requires, mean and Include its successors and assigns) of the “**SECOND PARTY**”

WHEREAS

THE FIRST PARTY AND THE SECOND PARTY believing that the process of college education can be enriched and academic understanding strengthened, and recognizing the benefits to their respective institutions from the establishment of academic links and cooperation, conclude this agreement.

WHERE AS the Memorandum of Understanding (MOU) as outlined in this document is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of those institutions involved and to suggest guidelines for cooperation. Nothing, therefore, shall diminish the full autonomy of either institution, nor may any constraints be imposed by either upon the other, and nothing in this Agreement shall be deemed to create a partnership, joint venture, or agency relationship between the parties.

WHERE AS, BOTH THE PARTIES are hereby agreed to jointly organize Training programme, Skill based programme, Seminars / Webinar, Online / Offline Faculty Exchange/Students Exchange Programs, Guidance Session, Workshops, Faculty Development Programmes for Teaching and Non-teaching staff with sole purpose of Academic Development of the students as well as the Teaching Faculty and sharing the Infrastructure and Know-how.

AND WHERE AS the College has shown interest to have the college tie-up with Second Party to enable the college to impart training or organize events and activities in Collaboration like Skill based programme, Seminars/Webinar, Faculty Exchange, Guidance Session Students Exchange Programs, Workshop, and the Faculty Development Programmes for Teaching and Non-teaching staff.

NOW THEREFORE IN CONSIDERATION OF THE PREMISES AND MUTUAL COVENANTS AND PROMISES MADE HEREINAFTER THE PARTIES HERETO AGREE AS FOLLOWS –

1. The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this memorandum of Understanding.
2. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed between the faculties, or institutes, which carry out the specific projects.
3. Financial and/or funding considerations shall become the subject of specific discussion and agreement within the framework of a separate implementation agreement. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.
4. It is understood that the implementation of any of the types of cooperation shall depend upon the availability of resources and financial support at the institutions concerned.



5. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
6. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon.

AND WHEREAS the Memorandum of Understanding shall remain in force for a period of **THREE years** from the date of the last signature and will be renewed automatically for the period of same duration unless it is revoked with the understanding that it may be terminated by the appropriate authorities of either party giving two (2) months' notice to the other party in writing, unless an earlier termination date is mutually agreed upon. AND

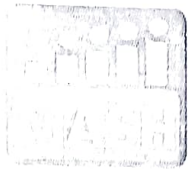
Excelssior Education Society's K. B. College of Arts and Commerce for Women, Thane (hereinafter referred to as the "**SECOND PARTY**").
